D. TERMS AND CONDITIONS

Application Procedure

- 1.1 Complete and return the Hostel Application Form together with the required rental for **One Academic Semester** and the refundable Security Deposit in order for this application to be processed.
- 1.2 Hostel availability is subject to the availability and is at the sole discretion of the College.
- 1.3 The College reserves the right to accept or reject any application at its discretion.
2. A hostel student must stay for **at least One Academic Semester** in order to avoid the forfeiture of his/her semester rental. Once withdrawn from the program, student is not allowed to stay in the hostel.
3. Should the student wishes to vacate his/her hostel at the end of his/her one year term, he/she will be required to give **30 days'** notice to the College. Failure to do so will lead to forfeiture of the Security Deposit.
4. Hostel accommodation is limited to active on-campus academic students only. Students are required to vacate his/her hostel after completing their final semester on campus and prior to the commencement of their internship placement.
5. Students wishing to reserve their places at the hostel for the start of every semester will be required to pay in advance the rental for each semester irrespective of whether they will be occupying the hostel or not. The Schedule of hostel payment is stated in the yearly academic calendar. Any late payment, a penalty of RM10 per day will be imposed. Failure to comply within 1 month after the schedule payment as stated in the academic calendar will result in eviction from hostel.
6. The hostels are reserved for outstation students only.
7. Cooking and misbehave are prohibited at any time at hostel. Non-compliance of this rule will result in the management disciplinary action of eviction.
8. The College reserves the right to change its rules and regulations as well as the hostel rental from time to time when it is deemed necessary.
